## The AA announces completion of strategic investment from Stonepeak

**Basingstoke, England & New York, NY** – The AA has announced that the conditions of the acquisition of a minority non-controlling stake by Stonepeak have been satisfied in full, resulting in the completion of the transaction.

Under the terms of the agreement, which was originally announced on 27<sup>th</sup> December 2023, Stonepeak, a leading alternative investment firm specialising in infrastructure and real assets, is investing £450 million in The AA through a combination of common and preferred equity at an enterprise value of approximately £4 billion. Following the closure of the transaction, Warburg Pincus and TowerBrook Capital Partners remain the majority shareholders of The AA.

The investment underscores Stonepeak's confidence in the continued progress The AA has made since it was taken private in March 2021. As reported at the time of the company's FY24 results, The AA has completed the first phase of its strategy and is now focused on accelerating growth and profitability. The additional capital from Stonepeak is being used to strengthen the balance sheet, enabling The AA to repay £180 million of Class B3 Secured Notes due 2050, as announced on 27<sup>th</sup> December 2023.

**Jakob Pfaudler, CEO of The AA, commented:** "We are delighted to confirm the completion of Stonepeak's investment in The AA as we embark on the next phase of our strategy. We look forward to the next stage of our growth, supported by Stonepeak and our majority shareholders Warburg Pincus and TowerBrook. This investment has allowed us to further deleverage whilst continuing to invest in our customers and people as we expand our digitised service offer to create long-term value for all our stakeholders."

**Nikolaus Woloszczuk, Senior Managing Director at Stonepeak, commented:** "We are thrilled to have completed this investment – Stonepeak's fifth in Europe – in what we view as not only a provider of critical transport services, but also an essential component of the UK's transportation system as a whole. We look forward to partnering closely with The AA's leadership team, in conjunction with TowerBrook and Warburg Pincus, to accelerate the company's growth."
